

# 行星命名酒會 慶饒公光耀天際

## 曾蔭權李剛詹永新曾德成駱文智等主禮

香港文匯報訊(記者 解玲)享譽海內外的「國寶級」漢學大師饒宗頤教授,昨日出席特地為他舉辦的「饒宗頤星」命名儀式暨慶賀酒會。特區政府行政長官曾蔭權,中聯辦副主任李剛,外交部駐港特派員公署詹永新,特區政府民政事務局長曾德成,廣東省人口與計生委書記、前潮州市委書記駱文智等出席主禮,共賀「香港之光、潮人之寶」饒公獲此殊榮。從此,浩瀚星空又多了一顆以中國人命名的璀璨小行星。

## 國學大師獲壽辰賀禮

香港文匯報訊(記者 解玲)小行星命名具有國際性、歷史性、唯一性和永久性,是一項崇高的國際榮譽。小行星「饒宗頤星」編號為10017號,由中國科學院紫金山天文台1978年10月30日觀測發現。今年7月17日,國際天文聯盟批准該小行星命名為「饒宗頤星」,並發表公告稱:鑒於饒宗頤先生是「世界著名的漢學家 and 書畫家,……曾在亞洲、歐洲和北美洲的著名大學講學,學術著作80多部,被稱為『導夫先路的漢學大師』」。同時,這喜訊成為饒公壽辰賀禮。

據中科院紫金山天文台楊捷興教授介紹,該小行星首次被發現時,距地球約1.72億公里,其繞

太陽呈橢圓運行一周需3.23年。

假如有宇航員到「饒宗頤星」上居住1年,回來時地球已過了4個春秋。

目前,宇宙空間中有100多顆小行星以包括香港知名人士在內的中国傑出人物、中國地名和中國的著名單位命名。為港人熟知的有:邵逸夫星、胡鴻烈星、楊振寧星、高錕星、曾憲梓星、陳易希星、徐克星等。當中,包括另外兩顆令潮人倍感親切和自豪的小行星——潮州星及陳偉南星。
