

官方認定 烏坎村委會重選

據新華社28日電 廣東省工作組村委會換屆選舉問題小組組長王葉敏28日在通報烏坎村第五屆村委會換屆選舉調查情況時表示，烏坎村第五屆村委會換屆選舉已被認定為整體無效，將盡快組織開展村委會重新選舉工作。在備受國內外關注的烏坎事件中，今年2月村委會換屆選舉不公是烏坎村民質疑和不满的主要問題之一。

廣東省工作組村委會換屆選舉問題小組情況通報會28日上午在烏坎村委會召開，200多名村民旁聽了通報會。王葉敏說，原村選委會是通過原村「兩委」幹部、村民小組組長和副組長、會計、企業代表、村黨員代表等50多人參加的會議產生，而不是通過「召開村民會議、村民代表會議或者各村民小組會議」的方式推選產生，違反《中華人民共和國村民委員會組織法》。

此外，原村民選舉委員會成員當選為村委會候選人後，退出村民選舉委員會的手續不完備，並且沒有公告；村民選舉委員會成員缺額後沒有依次遞補或者另行推選，也沒有公告，只是由剩下的5名村民選舉委員會成員組織選舉工作；有的村委會成員候選人繼續參與換屆選舉組織工作等情況，均違反《廣東省村民委員會選舉辦法》。

東海鎮黨委已決定成立烏坎村黨總支，暫時接替烏坎村委會工作。在烏坎村黨總支正式成立後，將成立由烏坎村黨總支成員、黨員代表、群眾代表、外出鄉賢代表等組成的烏坎村委會重新選舉籌備工作小組。王葉敏透露，在籌備工作小組前期工作的基礎上，將由村黨總支主持，重新推選產生村民選舉委員會；在村民選舉委員會的支持下，重新推選產生村民代表，重新選舉產生村民小組長，重新組織進行村委會的選舉工作。

省府全程監督新選舉

「感謝省工作組到烏坎開展迅速有效的工作，支持烏坎村民的合理訴求，依法對烏坎村第五屆換屆選舉做出整體無效的處理結果，並指導烏坎村建黨總支，為重新選舉村委會奠定了堅實的基礎。」烏坎村村民代表張水金、楊色茂等表示。

王葉敏表示，屆時，省工作組村委會換屆問題小組將派出專人現場指導，並由省、汕尾市、陸豐市和東海鎮的幹部以及烏坎村的外出鄉賢代表、村的群眾代表組成監督小組全程監督，確保烏坎村委會重新選舉工作圓滿完成。

內地校車安全標準參照美國

香港文匯報訊 據《新報》報道，記者從工信部獲悉，工信部裝備工業司就校車安全技術條件等四項校車安全新國標公開向社會徵求意見。新標準對校車車身結構、外觀標示、裝載質量等均作出明確規定，部分標準參照美國校車標準制定。此次徵求意見的最大亮點是幼兒校車首次進入國家標準的制定行列。

工信部方面透露，此次徵求意見的分別是由全國汽標委客車分標委修訂的《校車安全技術條件》、《校車坐椅系統及其車輛固定件的強度》、《幼兒校車安全技術條件》和《幼兒校車坐椅系統及其車輛固定件的強度》四項強制性國家標準。

在校車鋼板厚度上，《規定》稱，校車前後部應安裝厚度不小於5毫米的鋼板，車底板用1毫米厚的鋼板。此外，總質量大於4.5噸的校車，後輪應安裝雙輪胎，為降低校車在前、後碰撞事故中車輛受損的程度，要求校車加前後保險槓，這些都參照了美國校車標準。《規定》還要求學生坐椅不應是摺疊坐椅，副駕駛位置不得設置學生坐椅，學生坐椅在車輛橫向上最多採用2+3佈置，不得採用3+3佈置。每個學生坐椅都應帶有靠背和安全帶。

中國GDP能耗高國際逾倍

香港文匯報訊 (記者 馬靜 北京報道) 國家發改委主任張平28日受國務院委託向全國人大常委會作報告時指出，中國城鄉收入差距較大的局面尚未根本扭轉，要深化收入分配改革，逐步提高居民收入在國民收入分配中的比重，提高勞動者報酬在初次分配中的比重。他更在報告中透露，2010年中國單位國內生產總值能耗是世界平均水平的2.2倍。

城鄉收入失衡未扭轉

但張平同時表示，中國城鄉收入差距較大的局面尚未根本扭轉，區域發展的相對差距有所縮小，但絕對差距仍在擴大，欠發達地區和資源枯竭型地區發展面臨諸多困難。基本公共服務供給不足、不平衡的矛盾

仍十分突出，中西部地區公共服務與東部地區有較大差距，農村居民享受到的公共服務遠落後於城鎮居民。

張平在報告中指出，儘管「十一」時期中國節能減排和生態建設取得了積極成效，但能源消耗仍然偏高，環境污染仍很嚴重，生態環境仍十分脆弱。張平說，2010年中國單位國內生產總值能耗是世界平均水平的2.2倍，主要礦產資源對外依存度逐年提高，石油、鐵礦石等均已超過50%。

張平介紹，今年前三季度，中國單位國內生產總值能耗僅下降1.6%，氮氣排放量下降0.9%，氮氧化物排放量不降反升7.2%。固體廢物、危險廢物、持久性有機物等持續增加，重大環境污染事件時有發生。

「水立方」年虧損千萬求撥款

香港文匯報訊 國家游泳中心(俗稱「水立方」)有限責任公司副總經理楊奇勇27日在這裡舉行的全國體育局長會議上透露，2011年「水立方」的場館自營業務成本費用稅金總計高達9,929.9萬元，自營收入8,800萬元，需要通過政府相關產業資金支持才能達到收支平衡。

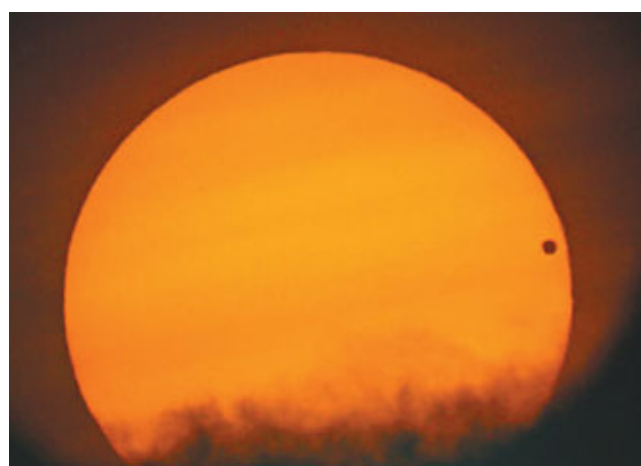
楊奇勇稱，2011年「水立方」共成功舉辦了68項151場次的體育賽事、大型文藝演出、企業活動等一系列大型活動，接待近14萬人次，但「水立方」賽後運營未來發展面臨維保成本高、周期性品牌體育賽事相對較少等實際困難，在履行場館公共體育服務重要職能方面，亟需政策扶植和產業資金支持。

「『水立方』2011年度場館自營收入8,800萬元，須通過政府相關產業資金支持，尚能達到收支平衡。同時，奧運旅遊參觀熱度繼續下降，大型場館的維保費用，勞動力成本普遍上漲，穩定、有規模的市場和收入來源尚未形成。」楊奇勇稱，本年度旅遊參觀遊客總人數同比下降了30%左右。

2012金星凌日 105年一遇

香港文匯報訊 據新華社電，2012年最令人期待的天象當屬金星凌日。中科院紫金山天文台研究員王思潮通報稱，明年6月6日金星凌日將上演，在天氣晴朗的條件下，從地球上看上去，金星將如一顆小黑痣，在6個半小時的時間內從太陽「臉上」緩慢走過。據悉，下一次金星凌日是105年之後的2117年。

據中科院紫金山天文台通報，將於2012年6月6日上演的金星凌日可見地區為歐洲(除極西南部)、非洲東部、亞洲、印度洋、大洋洲、太平洋、北冰洋、北美洲、南美洲西北部、大西洋西北部。中國中東部可見完整凌日過程，西部可見太陽帶凌而出。以北京地區為例，2012年6月6日將要上演的金星凌日將從早晨6時10分開始，12時50分結束。整個過程將持續6個多小時。

廣深高鐵分流春運 日運2萬客

香港文匯報訊 (記者 郭若溪，通訊員 許覺輝、劉洪毅 深圳報道) 2012年春運從1月8日開始，2月16日結束。28日下午，深圳市交通運輸委員會召開了深圳交通行業2012年春運工作暨春運安全大排查動員大會。據預測，2012年春運深圳市發送旅客量達976.40萬人次，同比增長2.60%。交委表示，廣深高鐵開通後，在春運期間，每日將可運送約2萬人次，為2012年春運分流。

福州動車撞死擅闖人

香港文匯報訊 (記者 戴鑫 福州報道) 福州至廈門的D6305次動車28日下午與一名進入鐵路的男子相撞，並致該人當場死亡。據南昌鐵路局披露，該次動車13點34分正當行駛至福州漁溪至莆田涵江區間，因撞人導致被迫停車18分鐘，此後D6305於15點23分安全到達廈門站。據初步了解，死者年約30來歲，係擅自攀爬柵欄進入鐵路。南昌局還表示，相關事故原因正在調查中。事故發生後，搭乘該列車的乘客便通過微博第一時間發佈了消息，並附上沾有血跡、已經凹陷開裂的車頭照片。這條微博也被眾多網友紛紛轉載。
