義女侍乞婦如母 借錢醫病養18載

自從謝阿婆今年4月初
摔倒骨折後，海南省村民李昌女就夜以繼日地照顧着謝阿婆。「這媳婦真好，把家婆照顧這麼好！」不明就裡的人看到後，都嘖嘖稱讚。實際上，謝阿婆既非李昌女的家婆，也不是她的母親，兩人沒有一點血緣及親戚關係。然而，李昌女卻把謝阿婆當成親娘，至今已贍養了18年。

「沒有這個女兒，我早死了。」謝阿婆逢人就嘮叨這句話。在謝阿婆的眼裡，李昌女就是她的親生女兒。

每天，飯做好後，61歲的李昌女就端着飯送到房裡給93歲的謝秋乾阿婆吃。晚上，她就打水提到房裡給謝阿婆抹臉擦身。謝阿婆想上廁所了，只要喊一聲，她跑過來抱着阿婆上廁所，然後再抱回房間。

完整家庭驟然破碎

謝秋乾阿婆命運多舛。她沒有生育，夫妻收養了一個兒子。後來老伴死了，養子婚後生了一個女孩；但不幸的是孫女患有精神

病，離家出走，結果患肺病死在外頭。兒媳婦改嫁後，養子也過世了。本來一個完整的家庭一下子變得支離破碎。1995年，75歲的謝阿婆做了一個改變自己命運的決定——離家流浪。

1995年農曆正月的一天，有一位臉黃肌瘦的阿婆來到李昌女家，向她討口飯吃，她知悉阿婆的不幸遭遇後，便說：「你要是不嫌棄，就在我家住下吧，我養你！」李昌女這樣說，「既然我碰上了，我就要管，否則我的良心過不去。」她收留謝阿婆時，丈夫符贊義讚揚她做得對，「生活苦點沒關係，不能讓阿婆再流浪了。」

兩場大病花掉10萬元

謝阿婆就這樣在這個「新家」裡活了18年，從75歲活到了93歲；而李昌女也從43歲的中年婦女成了子孫成群的61歲奶奶了，一家人和睦相處。

其後，謝阿婆患有肺結核，但李昌女不但沒有嫌棄，而且四處借錢。前年12月，謝阿婆又患心臟病等多種疾病，兩場大病先後花掉近10萬元，李昌女的善行令村民敬佩，「收養了一個與自己非親非故，而且又疾病纏身的阿婆近20年，這不是一般人能做到的，李昌女的行為值得讚揚。」一位醫生說。
