安徽省宣城市涇縣一戶人家近日在門口燒紙錢，女兒梅美鳳為瀕死的70歲父親梅愛根穿上壽衣。鄉間親友當晚自四面八方趕來，打算看老人最後一面。老人卻突然清醒「復活」過來，嚷着喊渴。從驚恐到欣喜，再到對醫院放棄治療的憤怒，梅美鳳的情緒好比過山車。

宅男的世界自有快樂！湖北武漢23歲宅男夏傳波每天和其他人說不上三句話，卻造出一台機械母狗陪自己聊天。「看著她每天說的話越來越多，我特別開心。」夏傳波近日接受採訪時捧着「她」笑呵呵地說。

「我沒有女朋友，又不愛出門逛街，除了上班就在住處窩着，標準的『宅男』。」宅在家裡時間長了，夏傳波也覺得沒意思。上大學時的小願望又漸漸浮上他的心頭：造個機器人陪伴自己。

自錄聲音變聲處理

夏傳波在漢口學院工作，專門從事機械製造。每天除了上班，他就窩在家裡，哪兒也不去，就在電腦上畫設計圖、裝配零件、錄製聲音，一個半米來高、外形似小狗，渾身纏滿電線、感應器的小「怪物」，漸漸成了型。夏傳波命名它為「波蘿五代」，並

梅美鳳憶述，父親當天因與母親爭執急了眼喝下農藥，下午送往涇縣人民醫院，搶救10分鐘後，醫生說老人情況很不樂觀，最好讓直系親屬來一趟，並下了病危通知書。「他們說我父親不行了，趕快準備後事，要麼送殯儀館要麼送回家。」

「我說父親興許有救，想去重症監護室看一眼。醫生說重症監護室一天好幾千塊，我父親肯定救不活了，沒必要這麼做。」梅美鳳說，父親被插了胃管、氧氣管，抬上救護車往家送。「他們說到家後把管子剪了，父親也就走了。」回家路上，梅美鳳開始招呼親戚朋友買壽衣、花圈。

到家後，梅家人拆了一塊門板，把老人抬到上面。事後梅美鳳自責，晚上溫度接近零度，父親就穿一件

壽衣，冷天裡躺了幾個多小時。

按農村習俗，梅家人替老人淨身、換衣、燒紙。過程中老人呼吸微弱，仍是昏迷不醒。然而，21時許，讓所有人震驚的是，老人醒了。

大家都以為是迴光返照，只有梅美鳳一個人壯着膽子靠近，「父親醒來第一句話是『好渴，我想撒尿。』當時我又是怕，又是高興！」

醫院稱家屬自願棄治療

當晚，梅家人把老人送往涇縣中醫院，經搶救，老人已脫離危險，且恢復意識。「同樣是醫院，為什麼這邊就能治？」對涇縣人民醫院放棄治療的做法，梅美鳳表示憤怒。

媒體記者前日聯繫上涇縣人民醫院副院長胡柏根，他否認了梅美鳳的說法，表示老人出院，純粹是病人家屬自願放棄治療，醫護人員操作並無不當。但據涇縣衛生局一位工作人員介紹，病人在救治過程中，直系親屬如果選擇放棄治療，肯定要跟醫院簽署一個自願放棄治療的協議，以防止後期出現糾紛。而這份協議，醫院卻拿不出來。

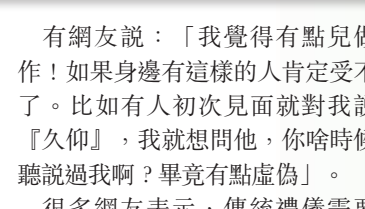
