區內經濟逐漸好轉 歐元反彈可望擴大


歐元上週初受制1.3820美元附近阻力後持續偏弱，並且一度於本週三反覆走低至1.3555美元附近5周低位。

歐元區自去年4月至11月間的失業率持續穩定在12.1%附近，反映歐元區下半年經濟逐漸好轉，明顯失業率沒有過於惡化。

此外，歐洲央行行長德拉吉早前曾發言淡化市場對歐元區可能出現通縮的憂慮。


