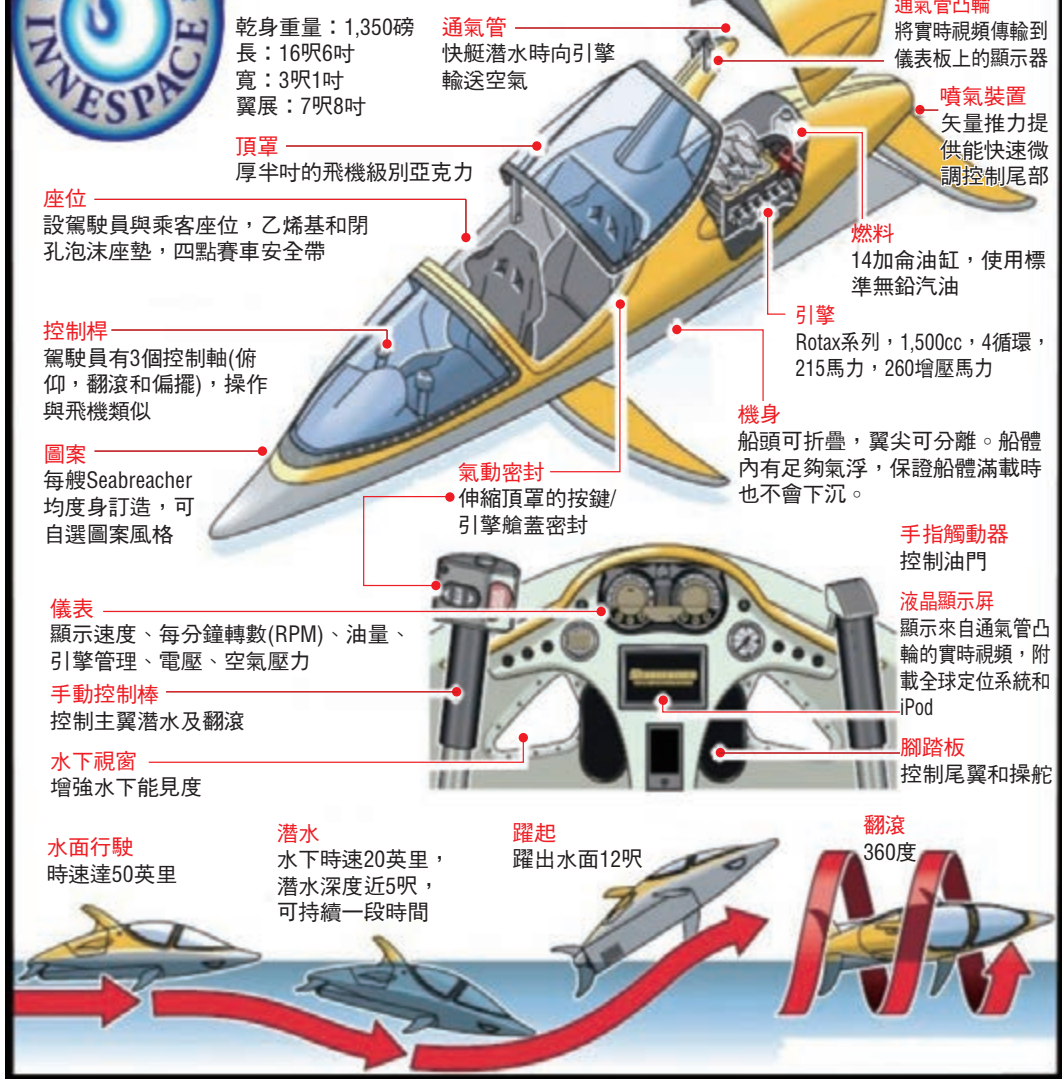




戰機變「鯊魚」

Seabreacher大解構



小心，鯊魚出沒！

澳洲有設計師將退役戰機改造成小型快艇，不但外形酷似鯊魚，還可模仿魚類潛水和躍起，每艘售價4萬英鎊(約51萬港元)起。若不喜歡鯊魚款式，也可按個人喜好，度身訂造殺人鯨或海豚模樣。

「Seabreacher」利用噴氣推進系統推動，附設的通氣管會不斷輸入新鮮空氣，防止引擎過熱，讓船身可潛入水中。此外，船身採密封設計防止滲水，船艙控制軸也保留戰機樣式。

可持續潛水20秒

快艇配備260馬力強力增壓引擎，可搭載一名乘客，時速高達50英里。每次可潛入水下數呎逗留20秒，衝出水面時，高度可達逾10呎，艇身幾乎與水面垂直。

變種怪貓 貌似狼人

美國田納西州一位繁殖者將加拿大無毛貓與黑色美國短毛貓配種，培育出一種眼耳口鼻邊無毛、像狗般忠誠友好的新品種。由於牠的面部極似狼人，繁殖者於是將牠名為「Lykoi」，這個字起源自希臘文的「狼」，可翻譯為「狼貓」。

列檢驗，發現這種貓沒有任何基因及皮膚病變，牠的毛皮之所以像斑禿，是因為部分毛囊完全沒有生成毛髮的所需元素，其餘毛囊雖可生出毛髮，但也難以維持，令狼貓換毛時可能有部分時間完全無毛。繁殖者強調，配種過程中沒有人為干預，只是利用加拿大無毛貓本身的基因變異。不過，由於狼貓身上找不到無毛貓的基因，意味牠是一個全新品種。

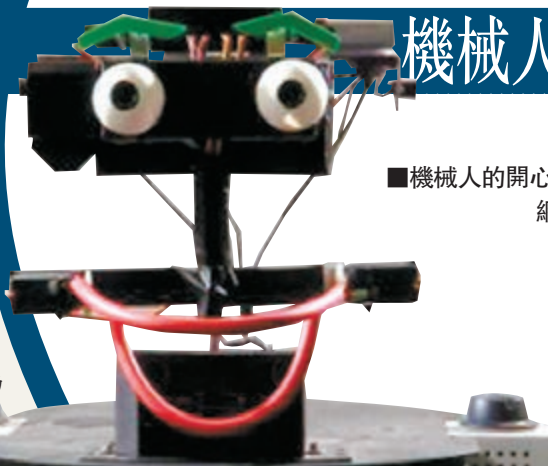
