

湯漢斯 奧巴馬伉儷群星齊祝賀 獲甘迺迪榮譽獎

美國時間12月7日，甘迺迪中心榮譽獎(Kennedy Center Honors)頒獎典禮2014於華盛頓甘迺迪中心盛大舉行，獎項旨在表揚藝人在演藝界的傑出貢獻，荷里活影星湯漢斯(Tom Hanks)及英國搖滾巨星Sting等人今年就獲得此榮譽，美國總統奧巴馬偕夫人米歇爾一同到賀，當晚到賀及表演的嘉賓包括美國百變天后Lady GaGa、美國R&B男歌手Usher及金像影后梅麗史翠普(Meryl Streep)等，場面星光熠熠。獲獎無數的湯漢斯興奮地表示，榮譽屬於大家的，在場的每一位都是贏家！

甘迺迪中心榮譽獎自1978年起開始頒發，藉此表揚對藝術和美國文化作出貢獻的傑出人士，而今年獲得此榮譽的藝人除了湯漢斯及Sting外，亦包括歌手Al Green、美國女演員Lily Tomlin及芭蕾舞家Patricia McBride。近日因胃酸倒流導致食道組織發炎的總統奧巴馬亦有偕夫人米歇爾出席，祝賀各得獎者，奧巴馬現身時笑容滿臉，精神似乎甚佳，湯漢斯的兒子Colin亦有與妻子擲場。諧星Stephen Colbert擔任頒獎禮主持，他開玩笑道：「今晚，華盛頓將藝術凌駕於政治上，因為無論你屬於甚麼黨派，你都只想跟湯漢斯玩自拍。」湯漢斯雖然獲獎無數，但他獲獎時亦難掩興奮之情，他表示拿甘迺迪榮譽獎與其他獎不同：「在一些充滿競爭性的頒獎禮，你需要花心思裝扮，但就只為了一晚，然後靜待台上呼喚你的名字，但你要足足六小時。」他又指今晚到來的每一位都是大贏家！Sting就表示能夠得獎感到很开心，因為對他而言是有點過譽，又指將來不知道會否再有機會獲獎。Lily就表示最高興是與奧巴馬見面，大讚他風趣又有趣，而且很有魅力及親切。

Upon the signature of the tripartite agreement, the Bohai No.3 would purchase the second-hand B737-800 liner from the TEAM CIGNUS LIMITED. The trading price would be USD29 million (about RMB 179.8 million yuan at the exchange rate of 1:6.2). The Company would lease the second-hand B737-800 liner operated from the Bohai No.3 with the monthly rental of USD 298 thousand for 96 months. The rental would be paid quarterly. A deposit for leasing of USD1.05 million shall be paid in advance.

Opinion of independent directors: The transaction would help to improve the flexibility of the asset allocation of its main business and financial status. It would optimize assets-liabilities structure and take positive influences on the future development of the Company. The related directors had abstained from voting. The procedure is legal and valid. No activity harming the interests of listing enterprise and all shareholders exists.

Voting result: 4 affirmative votes, 0 dissenting vote, 0 abstention vote and 3 avoiding votes.
