中秋將至，街上不少市民手拎月餅、柚子等應節美食。已漸漸淡出大家視野的豬仔餅、雙魚餅、獅子餅等公仔餅，近日卻在廣州番禺區小店中「重出江湖」，有市民更專程慕名前往購買。番禺街坊表示，節前買上一塊，細細咀嚼便可激發起童年與家人過中秋的溫情記憶。

在鍾村街的麒昌餅家櫃檯裡，陳列着外形趣致的獅子形餅點——亮黃色的浮紋外形、兩個黑眼珠、一隻四蹄輕揚的獅子躍然在目。店家梅姐說，公仔餅在上世紀三四十年前風靡番禺，是街坊過中秋必買給孩子的「象形月餅」。

公仔餅造型很多，如金魚餅、雙魚餅、獅子餅、仔公仔餅、豬仔餅（有餡）等，寓意吉祥，造型可愛。梅姐說，公仔餅興起後，經歷近20年市場競爭和飲食習慣改變等，番禺很多餅家已不再推出公仔餅，導致其逐漸退出中秋節美食的舞台。現在，還在售賣公仔餅的餅家僅剩下獅子的模具。她續說，特別是豬仔餅，因豬籠少見難買，整體成本高，現在幾乎不做。

不過，出於懷舊與保留傳統的想法，去年店裡決定重新做公仔餅。梅姐表示，中秋前，除了一些獵奇的年輕人前來嚐鮮，更多是「70後」、「80後」過來懷舊。

順德夫婦做公仔餅33年

距離番禺只有半個小時車程的順德勒流街道有一間名為「花季雨季」的餅店，店舖不大。61歲的店主馮聯英和70歲的丈夫羅劍明早在1982年開餅店，一直以來公仔餅很受街坊歡迎。如今，一家人生活條件越來越好，但依然堅持每年中秋前製作公仔餅。羅老伯說，做了這麼多年，捨不得這手藝停下來。令他們欣慰的是，孩子們都有孝心，每年在這個時期都會主動幫手做公仔餅食。



內地部分「最佳賞月地」

最美20賞月地 故宮瘦西湖入選

9月15日(明天)是一年一度的中秋節，賞月是節日裡的一大傳統活動。中國天氣網日前發佈了內地「最美賞月地」中秋節賞月指數，包括北京故宮、江蘇揚州瘦西湖等景區，成為內地20個「最美賞月地」。

據該指數分析，當天天空雲量低於五成，一般可以看到皓月當空或者彩雲追月。9月秋高氣爽，內地大部分地區尤其是北方的景區較適宜賞月。《人民日報》評選的20個「最美賞月地」景區1951年至2013年歷史數據分析，陝西西安—大唐芙蓉園、揚州—瘦西湖、北京—故宮、北京—盧溝橋、甘肅敦煌—月牙泉、安徽池州—平天湖、江西婺源—月亮灣、宜春—明月山、山東青島—嶗山等景區，明日雲量低於五成的概率超過70%，今年的中秋節很可能也會天朗月明。

不過，專家提醒，這是常年平均數據，不是預報，僅供參考。從目前的天氣預報來看，明日的天氣有些複雜，能不能與嫦娥相約，還要看天公給不給力。 ■《揚州日報》

侵華史料曝光 證日本蓄謀「九一八」事變

「九一八」事變85周年紀念日來臨之際，首次被發現的日本侵華歷史圖書《打倒日本》，昨日在遼寧瀋陽「九一八」歷史博物館對外公開。該書是創作於昭和六年(1931年)八月的日文圖書，企圖以「中國威脅論」的視角向日本民眾散播「中國要打倒日本，我們就要打中國」的觀點，為證明日本發動「九一八」事變蓄謀已久再添鐵證。此

外，當日還有多件由瀋陽市民間收藏家詹洪閣、裴復、高大航等無償捐贈的珍貴文物如「忠靈塔」、史料及原始照片等一同向社會公開。

標題現「中國威脅論」

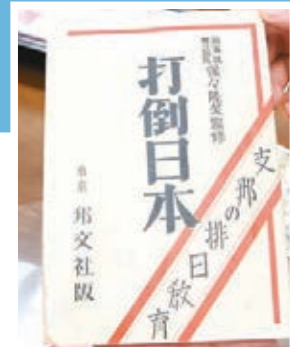
《打倒日本》一書是由已連續15年、先後20次向瀋陽「九一八」歷史博物館無償捐贈百餘件文物的民間收藏家詹洪

閣捐贈的。該書是在「九一八」事變前出版發行的極具煽動性的歷史圖冊，標題鮮明地表現全書主題，即所謂的中國威脅論，這也證實了「九一八」事變是必然的，早有預謀的。該書同時也是日本軍國主義促使「九一八」事變的誘因之一，也是首次發現、公開發表的珍貴圖書史料。

中國近現代史史料學會副會長、遼寧

省委黨校教授王建學認為，「九一八」事變前，日本在本國大造輿論、「教育」愚弄日本國民，而這一做法確與2001年以來時任日本首相小泉純一郎為修憲而大造輿論的實質具有一貫性，日本刻意迴避甚至歪曲歷史的做法，可以在該書中找到源頭，這是它重要的史料意義。
