香港文匯報訊 綜合台媒報道, 復興航空宣佈解散,台灣地區金融 監督管理委員會(金管會)主委李 瑞倉昨日表示,復興航空「動作那 麼快」,馬上召開董事會宣佈解 散,且上周五就已經成立信託專 戶,根本是預謀,「應該早就設計 好的」,非常惡劣。目前已掌握復 興航空大股東交易名單,若有內幕 交易,將以最嚴厲方式處分。至於 興航是否密謀解散,有待司法機關 詳查。

瑞倉昨日列席「立法院」財政委員會備詢,復興航 空解散成為「立委」質詢焦點。他在會中受訪時表 示,復興航空這麼快就召開臨時董事會宣佈解散,且上 周五委託律師開立兩個信託專戶,並未直接向銀行開立 信託專戶,顯然早有預謀,「應該早就設計好的」,完 全是欺騙社會大眾。

債權人傾向申請重整

此外,復興航空債權銀行團傳出傾向申請重整,李瑞 倉表示,除非興航有誠意還款,否則支持銀行團決定, 不准興航解散。

另一方面,台北地檢署偵辦復興航工停飛案,昨日上 午以證人身份約談興航3名業務員,還有1名高階管理人 到案,目前仍在調查局台北市調查處偵訊中,不排除移 送北檢複訊。檢方兩日內陸續以證人身份傳喚董事長林 明昇、總經理劉東明、財務長楊炫儀、法務長方修忠等 4人到案説明,訊後皆請回。

兩岸春節協調加班機

受到復興停飛影響最大的,目前當屬兩岸春節加班 機,不但復興航空13個大陸航點原有航班已訂位旅客, 得想辦法轉至其他航空公司,原本復興航空春節預定開 的加班機,也協調其他航空公司再增班。

「聽到興航停飛消息,我一夜難眠。」家住萬華的陸 配林姐焦急表示,為了返鄉過年,7月就訂了2017年1 月25日飛福建福州的機票,現在想再買年節機票,除了 難買、買不到,其他航空公司報的價格也漲了2倍以 上,「原本8,000元(台幣,下同)的來回票,現在買 變成了18,000元,搶錢啊!」
