
夥成龍拍《炮彈飛車》 美影星畢雷諾士逝世



曾與香港影星成龍及美國女星花拉科 茜合演《炮彈飛車》的荷里活老牌影星畢雷 諾士,前日在佛羅里達州一家醫院逝世, 終年82歲,演藝界人士和影迷紛紛在社 交媒體,留言悼念這位巨星及向他致敬。

拍裸照改變男性審美觀

畢雷諾士出生於美國密歇根州蘭辛市, 在大學時加入美式足球隊,後因傷患和車 禍退出賽場,在1957年參加演藝班,開始 他長達60年的影藝生涯,出道初期他曾當 過特技人,在1972年憑演出《激流四勇士》 走紅,他形容這是其最出色作品。在1981 年,畢雷諾士獲邀夥拍成龍演出《炮彈飛 車》,但票房成績不如預期。到1997年, 畢雷諾士憑《一舉成名》獲提名奧斯卡最 佳男配角,但他亦多次入選揶揄「年度爛 片」的「金酸莓獎」名單。

在1970年代,畢雷諾士曾為時尚雜誌 《Cosmopolitan》拍裸照,被指改變人們 對男性審美觀念,但畢雷諾士形容這是他 一生中最後悔的事。他兩年前接受傳媒訪 問時,憶述當時接受邀請的原因只是一時 衝動,不想被人小覷,與為藝術犧牲無 關。他表示照片曝光後不斷收到批評信, 而該期雜誌在短時間內賣出逾100萬本。
