歐聯爭位 下周重燃戰火 各隊發力搶分 英超復賽鬥後勁



停擺超過3個月的英超將於17日回歸，最開心的莫過於利物浦球迷，在聯賽榜以25分優勢遙遙領先，卻險些因為疫情而失落首座英超冠軍，復賽的消息無疑令「紅軍」上下鬆一口氣。英冠冠軍歸屬幾無懸念，至於曼城的第2名位置亦相對穩陣，餘下第3、4名甚或有機會後補參戰的歐聯位置爭奪戰，則是恢復最後9輪比賽的焦點所在。

曼城來季的歐戰禁令聆訊未有定案，一旦落實執行或會由排第5位的球隊補上歐聯席位之空缺，激發起一眾球隊爭先前列的動力。曼聯、狼隊甚至排名較後的熱刺及阿仙奴，均有機會競逐歐聯資格（詳見另表）。在財政受疫情重創下，獎金及轉播費非常豐富的歐聯席位隨時成為球隊的救命稻草。

紅魔新中場配搭備受期待

不少球星趁這3個月停賽期趕及傷癒，曼聯及熱刺成為最大得益者。停擺前走勢強勁的曼聯在聯賽重開後將有主將再回陣中，麥湯米尼及保羅普巴已經傷癒，主帥蘇斯克查希望解放普巴的入球能力擔任進攻中場，輔以冬季來投表現對辦的般奴費南迪斯發揮其組織力，加上麥湯米尼的防守，這條中場線將是「紅魔」爭入前四的最大本錢。熱刺前鋒荒也因停賽期得到紓緩，兩大王牌前頭哈利卡尼及孫興民復出攻擊，有助領隊摩連奴的戰術得到真正發揮。

護級形勢緊湊 6隊趕逃生

英超榜尾形勢亦相當緊湊，如無意外現時的英超榜尾6隊將會出現3支降班分子，第15位的白禮頓只以2分領先於降班區邊緣第18名的般尼茅夫，但餘下賽程卻要面對阿仙奴、李斯特城及曼聯等爭逐前四的球隊，又要硬撼利物浦及曼城，要逃離護級漩渦並不容易。韋斯咸及屈福特的賽程則較易應付，加上兩隊均有不俗的人腳，護級成功的希望是6隊中最高。至於般尼茅夫、阿士東維拉及諾域治，卻似乎難寄厚望可逃出生天。

東京奧運將以「簡化版」籌辦

國際奧委會（IOC）當地時間10日在瑞士洛桑以視頻形式召開會議，聽取了延期一年的東京奧運會最新規劃和籌辦進展，並與東京奧組委提出的東京奧運會新定位、路線圖和重新規劃表示認同，同意本屆奧運會新的定位將以運動員和體育賽事為核心，同時強調簡化、優化籌辦工作。

IOC主席巴赫透露，東京奧運籌備單位正在研究200份簡化東京奧運會的提案。他表示，新冠疫情當前，推遲舉行奧運是史無前例，IOC正與日方探討如何簡化奧運會並節省開支。東京奧組委主席森喜朗也強調，東京奧運不會有「宏大」的場面，將以「簡化的原則」籌辦奧運會，同時將全體參與人員的「健康和安

全」放在優先位置。由於新冠疫情蔓延，東京奧運已由原定今年7月24日開幕，推遲到明年7月23日至8月8日舉行。新華社/中新社

比賽和操練一度暫停超過兩個月，祖雲達斯主帥沙利坦言：復賽後球員受傷風險「相當高」。他又強調說：「這是前所未有的情況，帶來很多不確定性，而我們也沒能作熱身賽。我對近日訓練中所看到的感到不滿意，但一切到真正比賽卻未必一樣。」

雙方首回合賽和1:1，為「祖記」入球的基斯坦奴朗拿度已備戰充足，守將邦路斯和射手希古恩是役回歸主場亦可候命鬥舊會，至於新冠病癒的中場馬度迪和前鋒保羅羅巴拿則未知會否落場。停賽前意甲狀態明顯遜於榜首祖記的A米，後衛迪奧靴南迪斯、中場森姆卡斯特利祖和射手伊巴謙莫域今仗都或受傷或停賽缺陣，陣容不整殊不樂觀。
